CO-FINANCING LEVELS

expenditure commitments of the Russian Federation Regions are calculated taking into account the level of budget sufficiency, established by the Russian Ministry of Finance

FEDERAL SUBSIDIES LIMIT

for each Region is determined by the share of SMEs, operating in the Region, of the total number of SMEs

ADDITIONAL SUBSIDY

is available through the redistribution of the unclaimed volume of subsidies

Implementation of the Russian Federation legislation on the procurement of goods, works and services for state and municipal needs from SMEs


Development and approval of the roadmaps in the sphere of SME development for medium-term perspective and their publication in the official sites


PARAMETERS OF GUARANTEE

- More than 1 year
- More than \$28 thnd
- Less than 70% of the loan



SMEs ACCESS TO CREDIT FINANCE BY PROVIDING THE GUARANTEES FOR THE OBLIGATIONS OF SMEs

STATE GUARANTEE SYSTEM





EXPECTED RESULTS FOR 5 YEARS:

- Total volume of guarantees/sureties: \$21,5 bln
- Volume of loans: \$40,6 bln

MODERNIZATION:

Subsidies for the purchase of equipment, leasing contracts, interest rates on loan



Subsidies for interest rates on loans - up to \$283 thnd

Subsidy must be less than 2/3 of refinancing rate

Purpose of the loan is the industrial buildings construction for own needs, purchase of equipment

Recipients are legal entities and individual entrepreneurs

Average number of employees: without restriction from 2014 (before 2014: ≥ 30 pers.)

Payment of not less than 10% of the loan and not less than 10% of the interest on the loan

Subsidies for the purchase of new equipment - up to \$283 thnd

Recipients are legal entities and individual entrepreneurs

Average number of employees: without restriction from 2014 (before 2014: ≥ 30 people)

Subsidizing only the expenses for the purchase of equipment

Subsidies for leasing contracts - up to \$283 thnd

Equipment, referred to the secondary and higher depreciation groups of capital assets, the non-trading sector

Subsidizing the first payment is \$85 thnd (if < 30 pers.) and \$283 thnd (if ≥ 30 pers.)

Grants for startups are up to \$28 thnd if co-financed by the entrepreneur at least 15%

REQUIREMENTS TO THE CENTRE



Availability of machinery equipment or high-tech equipment

Staff of highly qualified professionals: production and design engineers, specialists in industrial design

Average production area should not be less than 20 sq.m. per PC employee

Average office area should not be less than 10 sq.m. per PC employee

Purchase of fixed assets

Communication services

Payment for the services of third parties

Utilities

Rent of premises

Other expenses

- Marketing research

- 37 centers are established in 36 regions

EURO INFO CORRESPONDENCE CENTER (Enterprise Europe Network)



- Facilitating EU market entry
- Assistance in the search of the potential business, technological, scientific partners
- Dissemination of information about Russian companies
- Exchange of commercial offers, requests and business information
- 45 centers are established in 42 regions



Facilitate SMEs enter the international markets of goods, services and technologies, improve their competitiveness

Social entrepreneurship and Centre for Social Innovation



SUBSIDIES TO SOCIAL ENTREPRENEURS

Providing employment for the disabled, mothers with children under the age of 3 years, graduates of orphanages, as well as persons released from prison - 50% of the employed

Social services to citizens, the production of equipment for people with disabilities, cultural and educational activities, social services

Maximum size of the grant is \$17 thnd

In 2013 allocated \$2 mln to 6 Regions of the Russian Federation

SOCIAL ORIENTED INNOVATION CENTERS

Assistance in business planning (selection of projects, assessment of the social efficiency of the project, the development of business models)

Legal support and consulting about the rights and preferences for social enterprises,

on accounting, preparation of financial statements

Training and certification, seminars of social entrepreneurs

Selection of the social leaders and the best social practices and their presentation on the open events

In 2013 it was allocated \$776,5 thnd to 7 Regions of the Russian Federation



Children's Centers



CHILDREN ACTIVITIES
CENTERS

Expenses include rent of premises, repair, purchase of equipment.

The grant is given in 3 stages.

Requires compliance with fire and sanitary requirements

Maximum volume of grant is \$28 thnd, own expenses of the entrepreneur should be at least 15%

In 2013 it was allocated \$2,6 mln to 17 Regions of the Russian Federation

PRE-SCHOOL CENTERS

Expenses include rent of premises, repair, purchase of equipment, the provision of educational services.

The grant is given in 3 stages.
Requires compliance with fire and sanitary requirements

Since 2014 recipient is an individual entrepreneur or legal entity before 2014 it was only individual entrepreneur

Maximum volume of grant is \$283 thnd covering no more than 50% of the incurred costs

In 2013 it was allocated \$1,8 mln. to 5 Regions of the Russian Federation



Youth Entrepreneurship Support



YOUTH ENTREPRENEURSHIP PROMOTION





Conclusion of the Agreement on cooperation between the Region of the Russian Federation that receive the subsidy and the Federal Agency for Youth Affairs (Rosmolodezh)

Trends in the framework of realization event, popularization, engagement, recruitment, training, support, ensuring the participation of young entrepreneurs in exhibitions, fairs

CENTERS OF YOUTH INNOVATION CREATIVITY





Maximum volume of grant to SMEs is \$198 thnd

Users are children and youth, SMEs

Priority is non-commercial use of equipment by children and youth to acquire skills on high-tech equipment

Equipment includes 3D printer, high-precision milling machine, lathe, laser cutting machine, cutting plotter, 3D scanner, soldering station, video communication, office equipment

Since 2012 the establishment of **74** Centers of Youth Innovation Creativity has been funded in **20** Regions of the Russian Federation

Folk Arts and Crafts



GRANTS FOR SMES THAT OPERATE IN THE FIELD OF CRAFTS AND FOLK ARTS

FORMS OF SUPPORT





Establishment of special infrastructure, including chambers of crafts, crafts centers, and centers for the development of rural and ecological tourism

Grants to support SMEs in the field of crafts and folk arts in all the foreseen activities



DEVELOPMENT, SAVING AND REVIVAL OF TRADITIONS OF FOLK ART

ENTREPRENEURSHIP SUPPORT:

Support Centers, Popularization, Education



CENTERS OF ENTREPRENEURSHIP SUPPORT

- financial, marketing and legal support for SMEs
- certification of goods, works and services
- recruiting services
- conferences, round tables
- consultations on the activities of the Institution of the Ombudsman under the President of the Russian Federation for the Protection of the rights of entrepreneurs
- The Board of Trustees of the center includes at least 50% of the representatives of the regional offices of All-Russian public organizations to support small and medium businesses
- The organization that provides consultancy to SMEs on the activities of the Ombudsman under the President of the Russian Federation for the Protection of the rights of entrepreneurs is on the basis of the Center

POPULARIZATION OF THE ROLE OF ENTREPRENEURSHIP

- production of television and radio programs
- publications in the media

SME participation in regional, inter-regional and national forums and conferences held in order to promote entrepreneurship

promotion of entrepreneurship in schools and universities

Consulting for SMEs on activities of the Ombudsman under the President of the Russian Federation for the Protection of the rights of entrepreneurs

SMEs EDUCATIONAL SERVICES

- granting of certificates
- training in the university

- partial payment of education
- education for youth and social entrepreneurship



SUPPORT OF SMES AFFECTED BY THE NATURAL DISASTERS



PROVIDING GRANTS (not more than \$17 thnd)

Documentary evidences, that SMEs property has been damaged

The reimbursement of costs to restart entrepreneurship

SMEs that insured their property are in priority

MICROFINANCE ORGANIZATION

Preferential interest rate is not more than 0.5% per annum

Provision and (or) prolongation of microloan up to 3 years

Subsidy to compensate regional MFO losses incurred by the provision of microloans to SMEs



MONOCITIES SUPPORT

Monocities with a population less then 50 thnd people



Max \$2,3 mln for 1 monocity

Monocities with a population from 50 to 300 thnd people



Max \$4,3 mln for 1 monocity

Monocities with a population more than 300 thnd people



Max \$8,5 mIn 1 monocity



SPECIAL INFRASTRUCTURE

BUSINESS
INCUBATORS
(min area 900 sq. m.)

Granting on favorable terms spaces for rent (the 1st year 40% of the average value for the region, for the 2nd year - 60%, 3d year - 100%)

Conducting of incubation processes (marketing, finance, investment planning, investment attraction, prototyping, production organization)

The building is older than 1970, not more than 50% of depreciation

TECHNOPARKS (min area 5000 sq. m.)

Introducing the concept of development, business plan, financial model

Expenditures of the federal budget include construction of communications, engineering infrastructure, purchase of equipment for collective use

PROMPARK (min area 20000 sq.m.)

Leasing of land, premises, providing of engineering, transport, logistics infrastructure, providing of energy and water supply and sewerage

Provision of the concept of development, business plan, financial model

Expenditures of the federal budget include construction of communications, engineering infrastructure, purchase of equipment for collective use
