# Our history



NEKK Industrial Group has been operating in the metallurgy and chemical industry since 1992.

In 2004 NEKK Industrial Group started working on launching production of Copper Sulfate.

In 2006 there was adopted technique of manufacturing of high-purity copper sulfates of feed and tech grades.

In 2007 manufacturing of feed grade copper sulfate was certified in accordance with HACCP system.

In 2009 manufacturing of feed grade copper sulfate was certified in accordance with FAMI-QS.

In 2009 to provide a support for international trade and marketing there was founded a European office - NEKK Europe Ltd. based in the UK.

In 2010 copper sulfate produced by NEKK OJSC was certified in accordance with REACH Regulation (reg. no. 01-2119520566-40-0018).

In January, 2015 copper sulfate produced by NEKK OJSC was certified in accordance with US FDA Regulations, that gave an opportunity to enter US and Canadian markets.

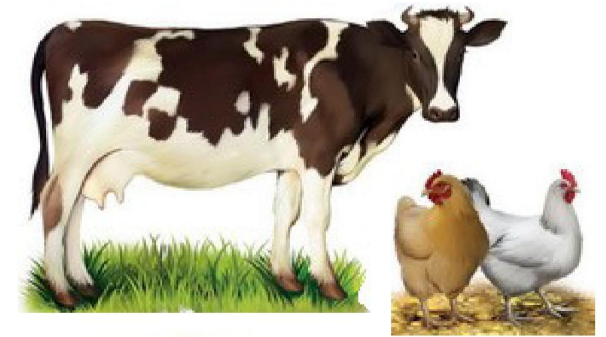

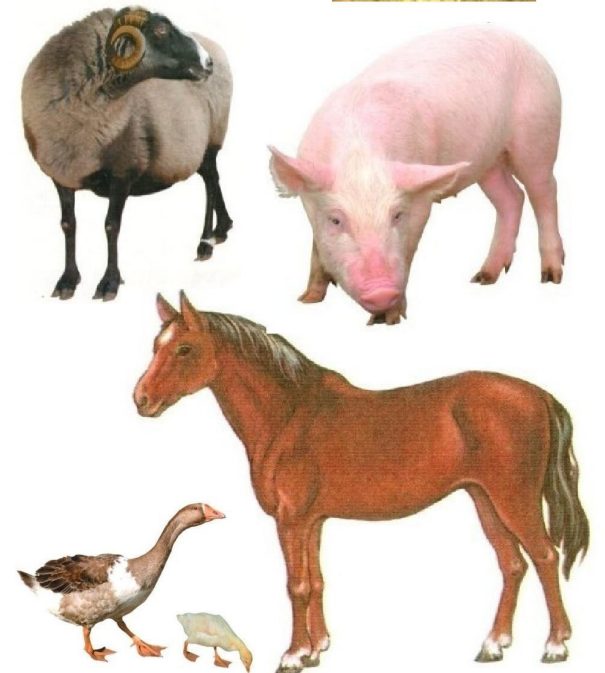
## OUR PRODUCTS: FEED GRADE COPPER SULFATE



Is used as an ingredient of animal feed in livestock and poultry husbandry, fishing industry.



Is produced in accordance with the requirements of FAMI-QS and HACCP quality control systems. The content of impurities, heavy metals and PCB dioxins is extremely low. There are four different grain size types. Our product is processed with anti-caking that makes it free-flowing during the whole period of shelf life (2 years).



## OUR PRODUCTS: TECH GRADE COPPER SULFATE

### USE:

- in agriculture as a plant-protecting agent for berries, fruits, vegetables and urban plantation (fungicide), for fertilization and wood protection;
- in minning for ore concentration;
- in petroleum industry;
- for manufacturing of double-sided printed-circuit board;
- in chemical industry for manufacturing of man-made fibre, varnishes, paints, arsenious chemicals, fabricated rubber products;
- in textile industry in fabrics rot proof.

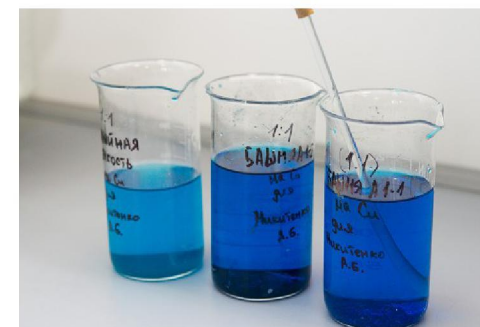
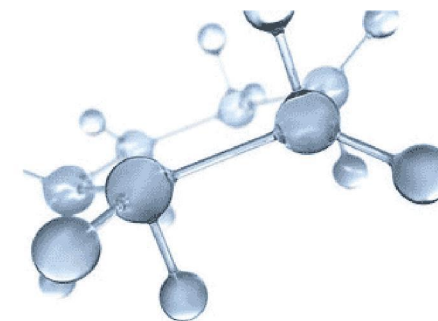
## OUR PRODUCTS: COPPER SULFATE OF ELECTRO-PLATING GRADE

### USE:

- in testing.

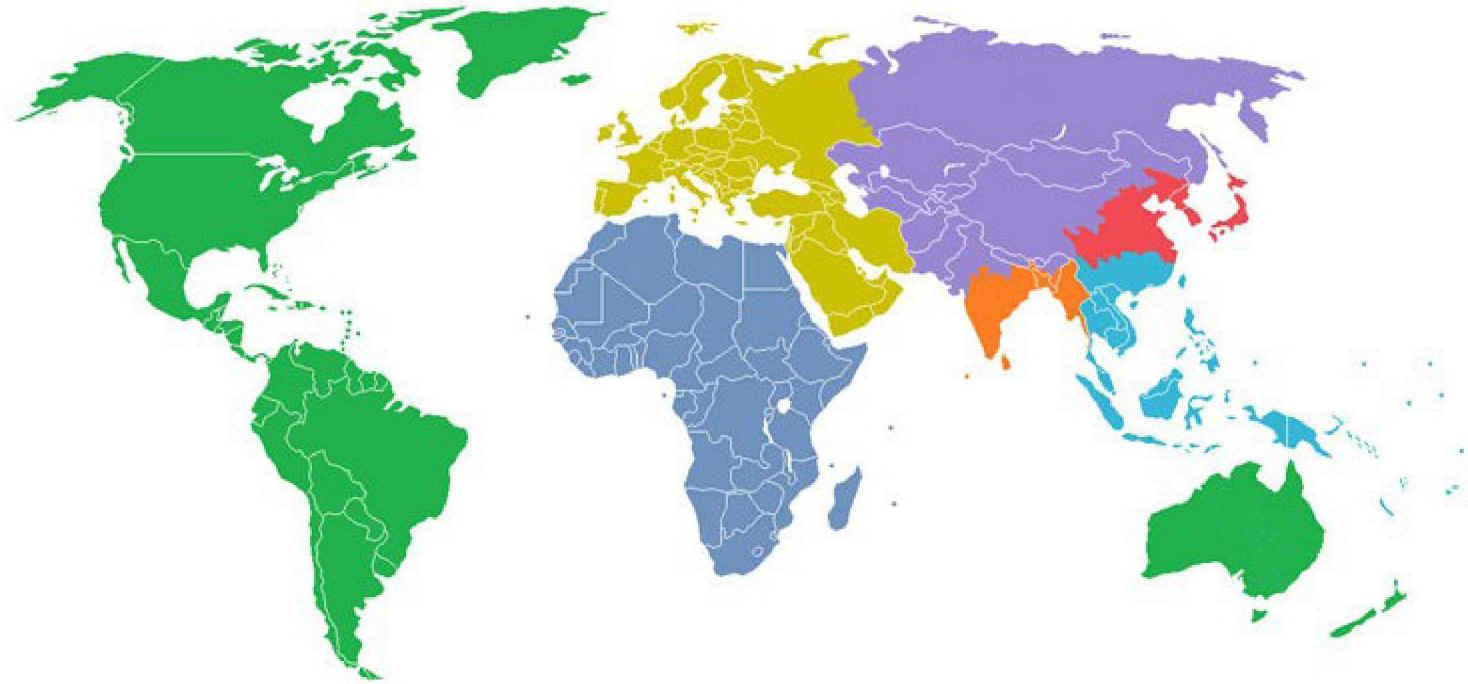
