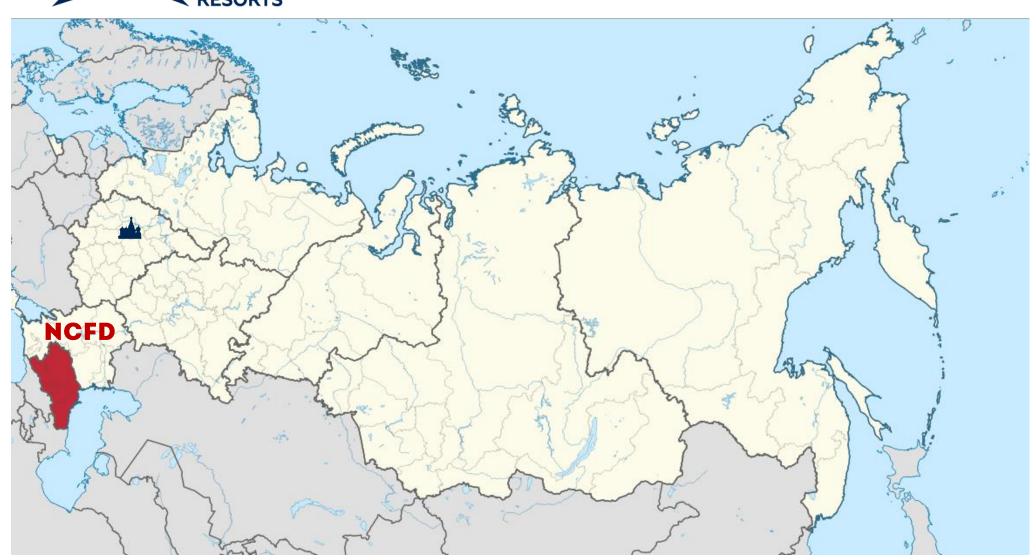

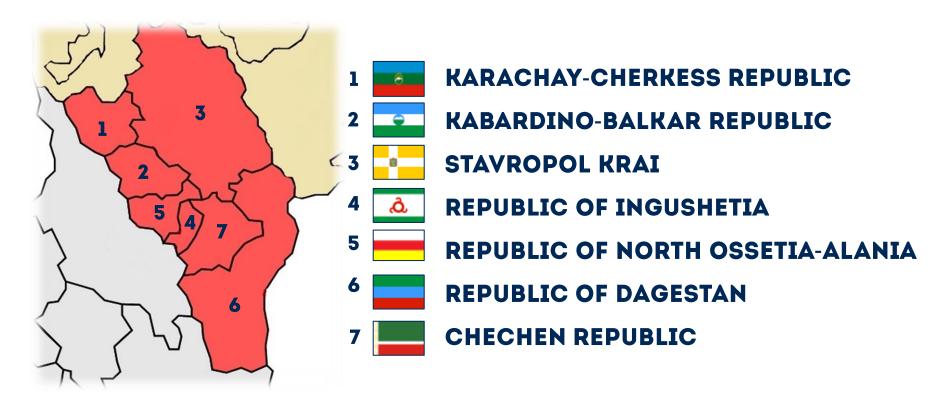


NORTH CAUCASIAN FEDERAL DISTRICT (NCFD)

POPULATION*



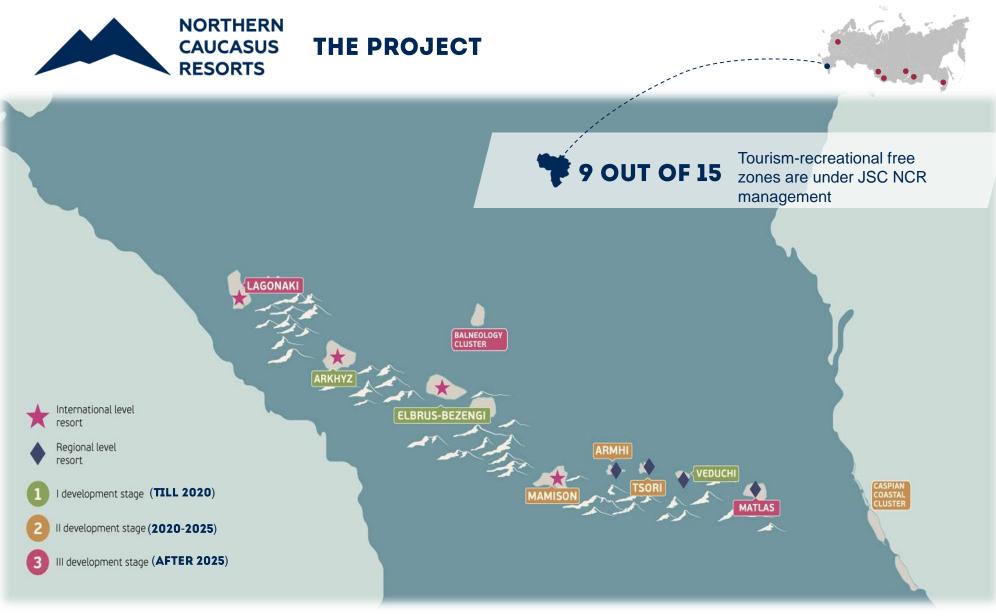

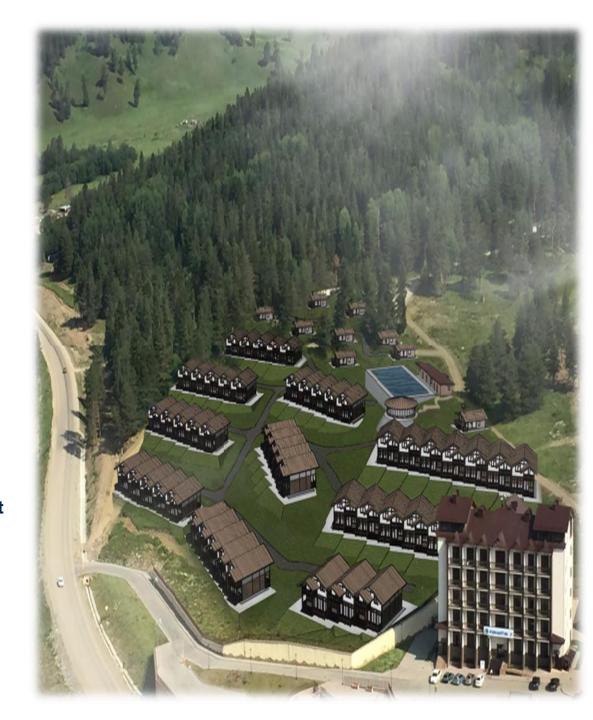

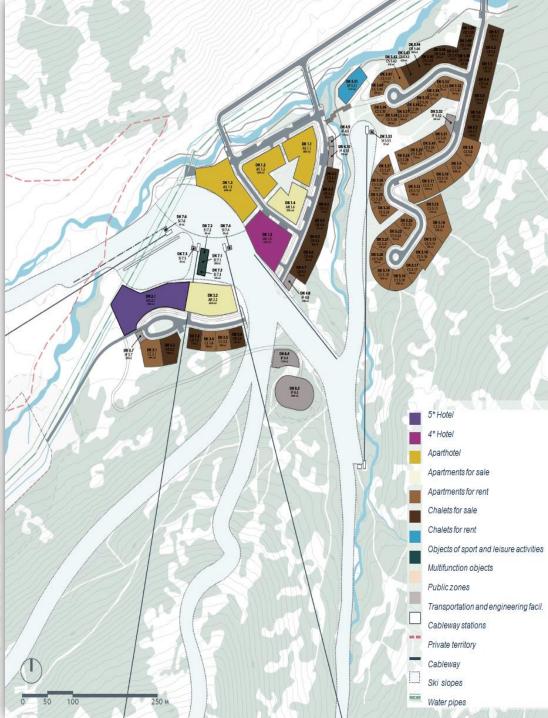
