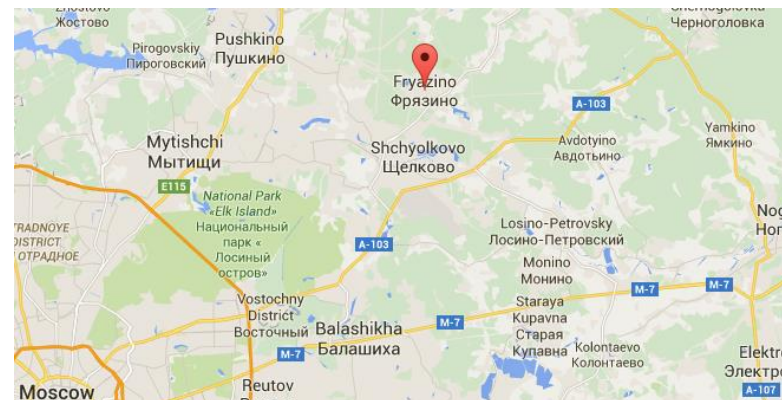


Electronic cluster inside the Technology & Development Special Economic Zone “Istok” (T&D SEZ “Istok”)

Fryazino - science town in Moscow region with high innovation potential



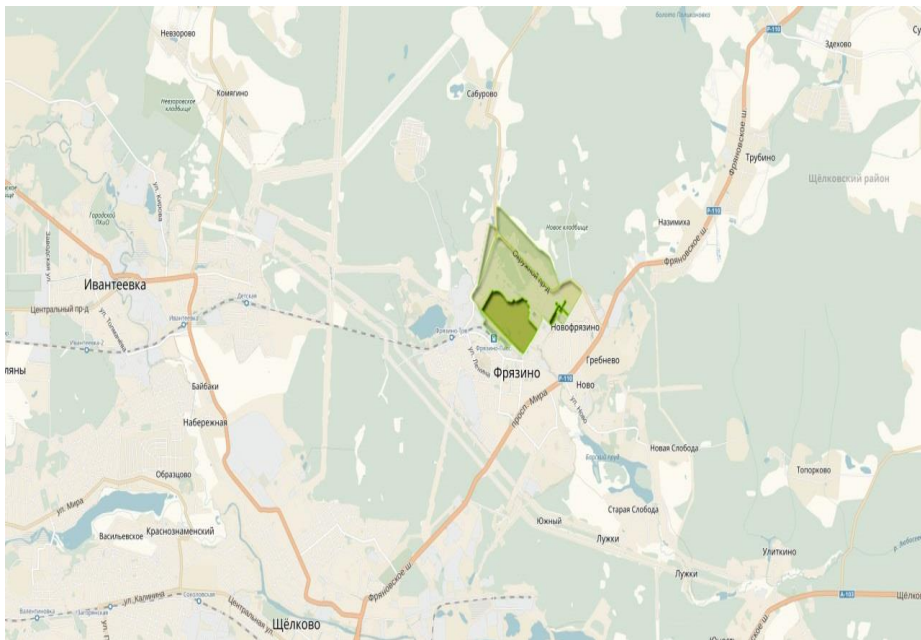
Population potential

- 59.8 th inhabitants
- 364 inhabitants with Phd
- 16% are engaged in high technology industries
- 2 Research Institutes:
 - Federal Institute of Radio Engineering and Electronics Russian Academy of Science named after V.A. Kotelnikov
 - Special Design Office - Institute of Radio Engineering and Electronics Russian Academy of Science

Transport infrastructure

- Auto:
 - 25 km from MKAD by Shchelkovskoye Highway
 - 35 km from Moscow center
- Railway:
 - Regular commuter train
 - Separate cargo entrance
- Airports: Sheremetyevo (SVO), Domodedovo (DMO)
- River ports: 60 km from Moscow Southern, Northern and Western port complexes

Exclusive privileges for residents in T&D SEZ “Istok”



- Special administrative regime implemented in "single window" format that reduces administrative barriers



- Simplified migration regime for foreign citizens engaged by T&D SEZ residents; it refers to a category of highly skilled professionals



- State guarantees for the whole period of the T&D SEZ existence (49 years), which are secured by the Federal Law 116 22.07.2005



- Free customs regime with zero VAT and customs duties rates



- Low rates for office and industrial premises rent



- Special tax regime including a reduction in income tax and no taxes on property, land and transport

To become a resident of T&D SEZ “Istok”

- 1 step**
 - Register of a Company in the urban district Fryazino Moscow region in accordance with the legislation of the Russian Federation
 - Not having subsidiary and/or representative offices

- 2 step**
 - Submit to the Management company for special economic zone «Istok» an application and business plan of the project which is to be implemented in the SEZ
 - Approve business plan via the SEZ Istok Supervisory Board

- 3 step**
 - Receive the approval of the business plan by the Expert Council at the Government of Moscow region

- 4 step**
 - Sign an Agreement on technological/innovation activities with the Government of Moscow region and the Management Company (during the operation of SEZ).
 - Become entitled with resident status
 - Perform technical/innovation activities, invest in your business
